NATIONAL GLASS PROGRAM PRICING

The Ford Fleet Care Glass Program offers more competitive pricing**. Windshield prices on the Ford Fleet Care Glass Program will be determined by the location where the windshield replacement is performed. States are divided into the following pricing categories:

- ☑ Windshield installation pricing for tier (1) states is \$295.00 plus molding and taxes
- ☑ Windshield installation pricing for tier (2) states is \$345.00 plus molding and taxes
- ☑ Windshield installation pricing for tier (3) states is \$445 plus molding and taxes
- ☑ Repair pricing is \$70 for the first, \$10 for the second, and \$10 for the third repair
- ☑ Pricing for parts that are "Dealer Only" items billed at Dealer List plus \$125.00 plus molding and taxes.
- ☑ Taxes are predetermined by customer or state law. Moldings, if necessary, are billed at Precision list
- ☑ Tempered pricing will remain the same at 50% off current NAGS plus \$24 Labor and \$18 kit.
